**The Servicemembers Civil Relief Act Has Moved**

**4.0—SCRA and SSCRA generally**

As is explained in Law Review 116<sup>3</sup> and other articles, Congress enacted the Servicemembers Civil Relief Act (SCRA) and President George W. Bush signed it into law on December 19, 2003. The SCRA is a long-overdue rewrite of the Soldiers' and Sailors' Civil Relief Act (SSCRA), which was originally enacted in 1917, shortly after the United States entered World War I.

Like the SSCRA before it, the SCRA has been codified in the "Appendix" of title 50 of the United States Code. This "Appendix" terminology is confusing, and no other title of the United States Code has an appendix. This "Appendix" has always been just as much a part of the United States Code as any other part.

Recently, the compilers of the United States Code eliminated the Appendix. The SCRA is now codified at sections 3901 and following in title 50.
