Membership Eligibility

Regular Membership – Any person who is an active, retired or former member of the federal uniformed services (as defined in 10 U.S.C. § 101) who at any time upon entering the federal uniformed services took an oath to uphold the Constitution of the United States, and, if no longer serving, whose separation occurred under honorable conditions, is eligible for Regular membership.

Associate Membership – Any person who qualifies for Regular membership, is under the age of 35, and has not previously been a member of the association, is eligible for Associate membership. It is free of charge and has a maximum term of five years, or until the member reaches the age of 35. Associate members have all the rights and privileges of Regular members except serving as an elected or appointed officer, voting at a national convention, and receiving printed publications.

Family Membership – Any person who is a spouse, widows, widowers, ancestors, and lineal descendants of anyone eligible for membership in the Association are eligible for membership.

Cadet Membership – Any Cadet or Midshipman actively participating in an ROTC program or Armed Services academy is eligible for membership.

Rights/Privileges – Regular members are accorded full rights and privileges as set forth in the Association's governing documents, including, without limitation, the right to vote and hold office.
